#### **Our Organisation's Structure**

Mackley is a provider of civil engineering services in the construction industry. We are a part of the Van Oord group of companies (Group), and our ultimate parent company is Van Oord NV which has its head office in The Netherlands located at Schaardijk 211, 3063 NH Rotterdam. Mackley has around 120 employees and operates in the United Kingdom and, from time to time, other countries.

We have an annual turnover of between £35 and £45 million.

#### **Our Business**

The principal activity of our company is construction and civil engineering.

### **Our Supply Chain**

Our supply chains include materials supplied by suppliers principally from the United Kingdom but we do have a small number of suppliers from various parts of the world.

#### Our policy on Slavery and Human Trafficking

We are committed to ensuring that there is no modern slavery or human trafficking in our supply chains or in any part of our business. Our Slavery and Human Trafficking Policy reflects our commitment to acting ethically and with integrity in all our business relationships and to implementing and enforcing effective systems and controls to ensure slavery and human trafficking is not taking place anywhere in our supply chains.

## Due Diligence Processes for Slavery and Human Trafficking

As part of our initiative to identify and mitigate risk we take all reasonable and practicable steps to ensure that slavery and human trafficking play no direct or indirect part of our business. We have in place general systems and controls to:

- Identify and assess potential risk areas in our supply chains.
- Mitigate the risk of slavery and human trafficking occurring in our supply chains.
- Monitor potential risk areas in our supply chains through due diligence.
- Protect whistleblowers.
- Promote corporate social responsibility which recognises our wider social and environmental responsibilities.

## Supplier Adherence to our values

We have zero tolerance to slavery and human trafficking. To ensure all those in our supply chain and contractors comply with our values we have in place a supply chain compliance programme. This consists of the routine training of applicable staff and the issuing of relevant policies and guidelines. We also assess new suppliers as regards anti-slavery and human trafficking practices or potential practices;
